1. Booth space will be available on a First-Come-First-Served basis. Electric spaces are limited.
2. Booth space is approximately 12' x 12' outside grassy area in Schnelker Park. Vendor is responsible for their own table and canopy top.
3. **Booth space fee is \$50.00 if received prior to May 7, 2018 for the 3 days.** After May 7th the fee is \$75.00. Electricity fee for the weekend, if desired, is \$5.00. Vendor will need to provide their own Heavy-Duty extension cord. Payment in full must accompany the signed application.
4. Setup time is Thursday, June 7th after 10a.m.
5. Sale hours will be Thursday and Friday 4:00-9:00p.m. Saturday 9am-9p.m.
6. **All items must be hand-made and of high quality. No buy-to-sell items will be allowed.** A photo of your product must accompany your application. Photo will be returned to you.
7. Full refunds will be given through May 7, 2018, no refunds after this date.
8. No vehicle parking is allowed in Schnelker Park during show hours.
9. Please provide a self-addressed, stamped, business sized envelope so we can send a welcome letter with your booth location map 2 weeks prior to the show.
10. Vendors must provide their own State Tax Certificate and be in compliance with all Indiana and local Fire Codes.
